**CERTIFICATION OF RESULTS – REVISED**

Pursuant to a signed letter agreement dated February 2, 2009 with Elio Giuliani, Treasurer for CSEA Westchester Unit 9200, hereinafter referred to as “CSEA,” the American Arbitration Association hereinafter referred to as the “Administrator,” agreed to conduct an officer election.

Three thousand five hundred and thirty nine (3,539) ballots were mailed to eligible voters on Tuesday, May 12, 2009. CSEA provided the Administrator with a list of persons who were eligible to vote. To be counted ballots had to be received by the Administrator no later than 9:00 a.m., Friday, June 15, 2009. During the course of the election, eighty one (81) duplicate ballots were issued at the request of CSEA members.

The counting of the ballots took place at the offices of the Administrator, 1633 Broadway, New York, New York on Friday, June 12, 2009 at 10:00 a.m. in the presence of observers. Of the one thousand five hundred and sixteen (1,516) ballot packets received by the Administrator, ten (10) were neither opened nor counted for the following reasons:

**2 – not on list of eligible voters**

**8 – ballots walked-in by someone other than the voter**


